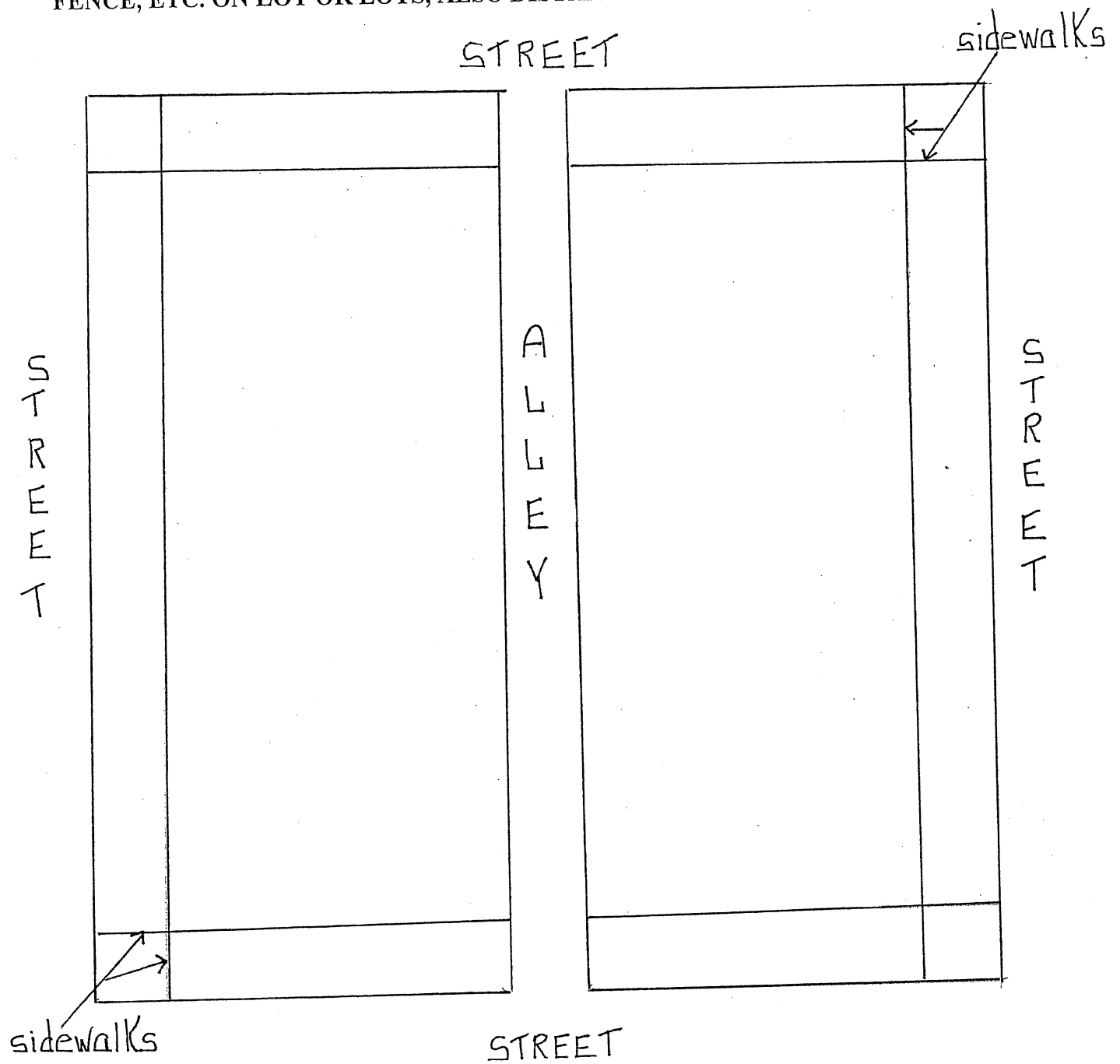

SIGN REGULATIONS

Notes to Table 10-3

Note 1: Maximum sign size is 200 square feet for civic or commercial uses, 2 square feet for residential uses, including home occupations.

Note 2: Maximum sign size is 100 square feet for project identification signs; 32 square feet for civic uses, 2 square feet for residential uses, including home occupations.

Note 3: Maximum sign size is 32 square feet for civic uses, 100 square feet for project identification signs for multi-family or mobile home developments and for non-residential uses when permitted, 2 square feet for residential uses, including home occupations.

Note 4: On premises with primary residential use, maximum sign size is 75 square feet for project identification signs for multi-family developments, 2 square feet for residential uses, including home occupations.

Note 5: In addition to its total permitted sign area, each premises used for a business center may have one detached center identification sign, subject to the following conditions:

1. The maximum area for a center identification sign shall be 150 square feet.
2. No center identification sign shall be within 300 feet of any other center identification sign or within 150 feet of any other detached sign on the same or adjacent premises.
3. The sign shall display no more than the name and location of the business center.
4. Each sign shall be subject to all other regulations for detached signs or graphics set forth in this Article.
